**Dear Sir/Shrimati Ji**

**In respect of correspondence with the school regarding your request, I send / am sending Affiliation of SCHOLARS PUBLIC SCHOOL JADLA, Shahid Bhagat Singh Nagar for 1st to 8th Class for the period up to 31st March, 2023.**

**The above accreditation is on the basis of the following conditions: -**

- 1. It is mandatory for accreditation beyond class VIII.**
- 2. The Right to Free and Compulsory Education for School Children Act 2009 and the Right to Free and Compulsory Education for Children comply with the provisions of the Rights Rules, 2010.**
- 3. The school expects 25% of the total number of classes in the first class, the weaker sections and the Non benefited Group will enroll the children of the pass and provide free and compulsory basic education till its completion.**
- 4. Reimbursement of expenses as per the provisions of sub-section (2) of section 12 of the Act for children in school will be done. The school will have to keep a separate bank account for this.**
- 5. The institution / school will not charge multiple capitation fees and there is no mechanism to select the child or his / her parents or guardians will adopt.**
- 6. The school will not deny admission to any child due to lack of proof of birth and will comply with the provisions of Section 15 of the Act. The school will ensure that: -**
  - (1) No enrolled child will be kept back in class or expelled from school when Until his primary schooling is completed.**
  - (2) No child will be subjected to corporal punishment or mental harassment.**

- (3) No child will be required to pass any board examination until completion of basic education.
  - (4) Each child who has received basic education will be given a certificate as per Rule 25.
  - (5) Involvement of students with special needs as per the provisions of the Act:
  - (6) Teachers are required to meet the minimum educational qualifications required under section 23 (1). Do But further condition is that the existing teachers who will get minimum educational qualifications at the time of implementation of this Act.
  - (7) Fulfills the responsibilities specified under Section 24 (1) of the Teachers Act.
  - (8) Teachers will not engage in private tuition.
7. Schools will follow the syllabus prescribed by the appropriate authority on the basis of the subjects taught.
  8. No unrecognized class will be conducted in or outside the school building under the same name of the school.
  9. The school building or other infrastructure or grounds shall be used for education and skill development only.
  10. School Society Registration Act, 1860 (1860 is being run by a society registered under 21) or by a trust created under an applicable law from time to time.
  11. The school is not being run for the benefit of any private group or group of individuals or any other person.
  12. Write which certified chartered accountant should be audited and write statement as per rules will be prepared. A copy of each audit table will be sent to the District Education Officer (AC) every year.
  13. Your school's accredited code No. RTE-401. This should be noted and recorded while dealing with this office.
  14. The school will provide the information requested by the District Education Officer from time to time and instructions from the appropriate authority or the District Education Officer to meet the conditions of accreditation or deficiencies in the functioning of schools will follow the instructions to remove.
  15. To ensure that the registration of the organization is renewed if necessary.
  16. The school shall comply with the conditions and standards prescribed in section 19 of the Act.
  17. Letter is issued by the Government of India for the Right Of Children to Free and Compulsory Education (Amendment) Act, 2017 No. 24 of 2017 Date 9 August 2017. the terms of the will apply.
  18. At the time of School Fire Safety Certificate, Building Safety Certificate and Water Purity Certificate will be bound to renew as and when required.
  19. If any of the documents submitted online by the School is found later to be incorrect then the Affiliation of School can be canceled.
